1. CALL FOR N.8 STUDENTS MOBILITY FROM FOREIGN UNIVERSITIES

The Ministry of University and Research, in implementation of sub-measure T4 “Transnational initiatives in education”, Investment 3.4 “University teaching and advanced skills” of the National Recovery and Resilience Plan, Mission 4 “Education and research” – Component 1 “Strengthening the provision of education services: from nursery schools to University”, promotes the implementation of transnational educational initiatives (TNE). In the project TNE2023-00012 – CUP D74G23000280006. PNRR_TNE_2023 “GPS^{Education} – Green & Pink for Sustainable Education”. Lead institution: University of FOGGIA.

A selection process is announced for the assignment of mobility grants for study, internships, and thesis research. The mobility must be completed within the 28/02/2026 and it involves the University of Modena e Reggio Emilia (UNIMORE) foreign partner universities reported in the table of Annex A.

1.1 Article 1 – Eligible students

Students who, at the time of application and during the mobility period, are regularly enrolled in master's degree or PhD program at one of the partner universities listed in Annex A are eligible to participate in the selection process. Failure to meet the aforementioned requirement will result in the inability to carry out the mobility program at UNIMORE.

1.2 Article 2 – Application submission

Selection is at the counter, i.e. based on the order in which applications are received. Applications must be submitted using the specific Application Form (ANNEX C) for students available at direttore.scienzevita@unimore.it

The deadline is 25 July 2025.

The following documentation for students must be attached as PDF file to the application:

1. Self-certification or documentation proving enrollment at home university and list of completed exams.
2. Self-certification of a bachelor's degree or of a master's degree, including the final grade (for candidates enrolled in a master's degree or Ph.D. program).
3. Curriculum vitae (CV or resume).
4. One-page motivation letter.
5. A valid ID document.

The Nomination will be sent to successful students immediately after the ranking publication.

Students that for any reason renounce the mobility must promptly reply to it within 5 days of notification of selection.

Further information and documents will be sent only to those students accepting the nomination.



1.3 Article 3 – Duration of mobility and financial support

The students' mobility period has a maximum duration of 4 months (120 days). The travel days are excluded from the mobility period.

Financial support must be considered to cover the expenses related to travel and stay abroad.

The amount is related to the days of actual stay in the host institution. In particular, the funding is as follows:

- 1) **1.300,00 €/month** for VISA, health insurance, food, accommodation, local transports, etc. (Annex B),
- 2) **up to 1.735,00 €** for round trip flights (tickets will be provided by the host university directly to candidates).

1.4 Article 4 – Allowed activities

The following activities are allowed during the students' mobility period, depending on the duration:

- Attending courses and workshops.
- Taking exams.
- Research aimed at thesis preparation.
- Internships.

All the activities must be completed by 28/02/2026.

1.5 Article 5 – Insurance

UNIMORE offers insurance coverage for accidents and third-party liability at the study/work site for all participants.

UNIMORE strongly recommends the students involved in the exchange to individually provide to sign adequate health insurance and travel insurance coverage during their stay abroad, under the regulations of the host country.

1.6 Article 6 - Personal Data Processing and Confidentiality

According to the D.Lgs. 196/2003, the treatment of the personal data will be exclusively carried out for institutional purposes related to this announcement; according to the law n. 241/90 e ss.mm.ii.
